NEW – Two-Year Eligibility Option

RDO Caters Taters is committed to supporting organizations in a way that provides flexibility and long-term impact while also being mindful of administrative burdens. Beginning in 2026, applicants may choose one of the following participation options.

- 1. Apply for 2026 Only:** Organizations may submit their materials for consideration for the 2026 event year. If selected, participation applies solely to the 2026 event.
- 2. Apply for 2026 with Automatic Eligibility for 2027:** Organizations may elect to have their 2026 application remain active for the following year. If the organization is not elected for 2026 event, the same application will automatically be carried forward for consideration in 2027 - no resubmission required. *If selecting this option, please frame your responses to cover more than one year.*

Guidelines for Applicants

RDO Caters Taters seeks to create positive impact on our community while supporting organizations that align with RDO's values.

Therefore, priority will be given to organizations who serve:

- People in crisis
- People seeking to improve or advance their lives and the lives of others
- Veterans and First Responders
- Community enhancement
- Children, young adults, and the elderly with needs for support services

Causes and organizations that fall outside the scope of RDO Caters Taters:

- Those not serving Fargo/Moorhead
- Those primarily focused on the arts
- Those primarily focused on animal rescue / animal welfare
- Those focused on benefiting political parties, campaigns, and candidates
- Those primarily focused on religious programming
- Those focused on a singular club, school facility, district, or sports team

Charity Requirements: to be eligible to apply for RDO Caters Taters, your organization must:

- Have an operating budget of \$100,000
- Have a minimum of two staff members
- Have effectively facilitated a raffle
